

## Your Pass to South America Sweepstakes

Official Rules

### **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR CLAIM PRIZE. NON-PURCHASE AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING.**

- 1. ELIGIBILITY:** The Your Pass to South America Sweepstakes ("Sweepstakes") is open to legal residents of the fifty (50) United States and the District of Columbia, who are 18 years of age and older as of October 1, 2013. Employees of U.S. Bank National Association ("Sponsor"), LATAM Airlines Group S.A. d/b/a LAN Airlines ("LAN Airlines"), their respective subsidiaries, affiliates, and advertising, promotion and service agencies including, without limitation, Marketing Resources, Inc. ("Administrator"), any company who processes transactions and maintains account information for the LANPASS® Visa credit card issued in the U.S. and the immediate family members (spouse, parent, child, sibling, grandparent, and spouse or "step" of each) and those living in the same households of any such individuals (those persons whether related or not who live in the same residence for at least three months during the twelve-month period preceding the start date of the Sweepstakes) are not eligible to participate. Void where prohibited by law. Sweepstakes is subject to all applicable federal, state, and local laws and regulations.
- 2. SWEEPSTAKES PERIOD:** Sweepstakes begins on October 1, 2013 at 12:00:01 am Central Time ("CT") and ends September 30, 2014 at 11:59:59 pm CT (the "Sweepstakes Period").
- 3. HOW TO ENTER:** A LANPASS Visa® credit card cardmember ("Cardmember") in good standing will automatically receive one (1) entry into the Sweepstakes for every \$1 in net eligible purchase transactions during the Sweepstakes Period with a LANPASS® Visa credit card ("Card") anywhere Visa credit cards are accepted. The following transactions are not eligible and will not receive one automatic entry into the Sweepstakes: cash advances, ATM transactions, traveler's check purchases, balance transfers, credit insurance premiums and other non-purchase transactions, as well as bank account fees, service charges or interest charges of any kind. Sweepstakes entries for foreign transactions will be calculated based on U.S. Dollars as of the date of purchase using Visa's standard exchange rate. Cards that are lost, stolen, fraudulent, tampered with or otherwise altered are not eligible for automatic entry. Entries based on purchases that are returned for credit or refund will be voided. All entries will be deemed to be submitted by the primary account holder, regardless of whose name the Card used to make the qualifying transaction that resulted in an entry was issued.

**To enter without purchase or other obligation:** Hand-print your name, address (no P.O. Boxes), city, state, ZIP code, day and evening phone numbers and the words "Your Pass to South America Sweepstakes" on a 3" x 5" card, and mail it in a stamped #10 envelope to: Your Pass to South America Sweepstakes Alternate Means of Entry, P.O. Box 791, Elmhurst, IL 60126 (each an "AMOE"). AMOE's must be postmarked by September 30, 2014 and received by October 7, 2014. Limit one (1) submission per postmarked envelope. Proof of mailing does not constitute proof of delivery. Entries that are mechanically reproduced, copied, illegible, incomplete, postage-due and all entries that by any means subvert the entry process are void, as determined in Sponsor's sole discretion. Each valid AMOE submitted will receive 86 entries into the Sweepstakes. Entries become the property of Sponsor and will not be returned.

- 4. DRAWINGS:** Four (4) random drawings from among all eligible entries will be conducted by the Administrator, an independent judging organization, on the dates set forth in the drawing table below to award the prizes specified in the drawing table for each drawing. Non-winning entries will be carried over into and be eligible for subsequent drawings. The Administrator's decisions are final on all matters relating to the Sweepstakes drawings.

Entries for transactions processed between the start and end date for each Drawing Period and all AMOE's received during the same period will be included in the corresponding Drawing Period drawing.

- 5. PRIZES/ODDS:** One (1) Grand Prize: Grand Prize winner may select one (1) trip for winner and one (1) guest from the five following packaged destinations: (1) 3 nights in Buenos Aires and 2 nights in Mendoza, Argentina; (2) 2 nights in Santiago and 3 nights in Atacama Desert, Chile; (3) 2 nights in Bogota and 3 nights in Cartagena, Colombia; (4) 3 nights in Quito and 2 nights in Guayaquil, Ecuador; or (5) 2 nights in Lima and 3 nights in Cusco, Peru.

Trip prizes includes round trip economy class air travel from a major gateway served by LAN Airlines (Airport codes: LAX, SFO, JFK, , MIA) to the destination of Grand Prize winner's choice, double occupancy hotel accommodations at a 4 or 5 star hotel and a \$2,500 Visa pre-paid card (for the Grand Prize winner only). Approximate Retail Value ("ARV"): \$8,000. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated ARV and the actual value of the prize will not be awarded.

Three (3) First Prizes: 100,000 LANPASS Miles awarded to the winner's LANPASS account. ARV: \$3,200. If winner does not have a LANPASS account, he or she will be required to sign up for a LANPASS account and signing up for a LANPASS account is free. Odds of winning a drawing will depend on the total number of eligible entries received for each drawing. Limit one (1) First Prize per person. Total approximate retail value of all prizes \$17,600. - 6. PRIZE RESTRICTIONS:** Prizes are not transferable and no substitution of prize or portion thereof is permitted except at the sole discretion of the Sponsor. Federal, state, and local taxes on prize and any expenses relating to the acceptance of and use of prize not specified herein are the responsibility of the winners and winners will be issued an IRS Form 1099 for the actual value of the prize. Grand Prize winner's guest must be 18 years of age or older and not considered a minor in his or her state of residence, or accompanied by a parent and/or legal guardian. Trip must be booked within 30 days of prize claim by Grand Prize winner and verification by Administrator. Grand Prize winner and guest must travel between November 15, 2014 and November 15, 2015 and must travel on the same itinerary. Travel dates are subject to availability and subject to blackout dates (12/9/14 – 2/28/15; 3/21/15 – 3/30/15; 6/7/15 – 8/20/15 and 9/12/15 – 9/22/15) and other restrictions may apply. Airline and hotel accommodations will be determined by Sponsor. Grand Prize winner and guest are responsible for complying with all security requirements for travel, and having all required valid travel documents including passports and any tourist visas if applicable. Sponsor will not replace any lost or stolen tickets, travel vouchers or similar items once they are in the Grand Prize winner's or guest's possession. Grand Prize winner is responsible for all costs and expenses not stated or provided for herein, including applicable taxes, airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to acceptance and use of the Grand Prize. Grand Prize winner and guest are responsible for their own travel to the major gateway airport served by LAN Airlines. Guest of Grand Prize winner must sign and return a travel liability release before travel will be booked. If the guest is at least 18 but still considered a minor in his or her state of residence, the travel liability release must also be signed by the winner's parent or legal guardian. No changes can be made to any trip element once it is booked and reserved, and Sponsor does not guarantee transportation and accommodations will be available on the exact dates requested by Grand Prize winner. Airline tickets are subject to flight variation, work stoppages and schedule or route changes. Sponsor is not responsible for any cancellations, delays, diversions or any acts or omissions by air carriers, hotel operators or any person providing any Grand Prize related services. Grand Prize winner and guest are responsible for obtaining travel insurance, and all other forms of insurance, at their option and acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance. If a Grand Prize winner or guest at least 18 but still considered a minor in his or her state of residence, he or she must be accompanied at all times during the trip by his or her parent or legal guardian.
- 7. NOTIFICATION OF WINNERS:** Potential Prize winners are subject to verification, including verification of age, and will be contacted via a traceable method of delivery and will be required to complete, sign, and return an Affidavit of Eligibility/Liability Release, and, where lawful, a Publicity Release (granting the use of the Winner's name, city/state, likeness, or photograph by Sponsor for advertising/publicity purposes, without further compensation) within ten (10) days of attempted notification or prize will be forfeited and may awarded to an alternate winner. If a winner is at least 18 but still considered a minor in his or her state of residence, the Affidavit of Eligibility/Liability Release and Publicity Release must also be signed by the winner's parent or legal guardian. If Sponsor is not able to contact a potential winner within a reasonable period of time, if any potential winner is found not to be eligible or not in compliance with these Official Rules, if prize notification or prize is unclaimed or returned as undeliverable, or if prize is rejected, the potential winner will be disqualified and the prize will be forfeited and may be awarded to an alternate winner.

- 8. ADDITIONAL TERMS:** By participating in this Sweepstakes, entrants agree: (a) to these Official Rules and to the decisions of the Sponsor, Administrator and the judges, which shall be final in all respects; and (b) to release, discharge and hold harmless Sponsor, Administrator, LAN Airlines, and their respective affiliates, subsidiaries, and advertising, promotion and service agencies involved in this Sweepstakes and their respective parent companies (collectively "Releasees"), from all liability, claims, damages, injuries or death arising out of or related to, directly or indirectly, their participation in the Sweepstakes and their acceptance, use or misuse of any prize; and (c) by acceptance and use of a prize, to the use of their names and/or likenesses for advertising and publicity purposes by Sponsor and its agents in all media without compensation, except where prohibited by applicable law.
- 9. LIMITATIONS OF LIABILITY:** Releasees are not responsible for lost, late, misdirected, damaged, incomplete, illegible or postage-due mail or entries, or for transactions that are processed late or incorrectly or are lost because of computer error or malfunctions or for transactions that are not processed through U.S. Bank or other authorized processing system. The Sponsor reserves the right to cancel, suspend or modify the Sweepstakes, or to disqualify any entry or entrant, at any time with or without notice to entrants or Cardmembers if fraud or technical failures compromise the integrity of the Sweepstakes as determined by the Sponsor in its sole discretion and Releasees shall assume no responsibility to entrants or Cardmembers in such case. In the event that Sponsor deems it necessary to cancel the Sweepstakes, prizes will be awarded in a random drawing from all eligible non-suspect entries validly received as of the time of cancellation or prior to the act or event that caused cancellation of the Sweepstakes. This Sweepstakes is offered only in the United States and is governed by the laws of the state of Minnesota, and entrant consents to jurisdiction and venue in, and agrees that all claims and disputes must be resolved in the federal or state courts in Minnesota. Entrants agree that Releasees have not made nor are in any manner responsible or liable for any warranty, representation or guaranty, statutory, express or implied, related to this Sweepstakes.
